**(Note this is a changed date)**

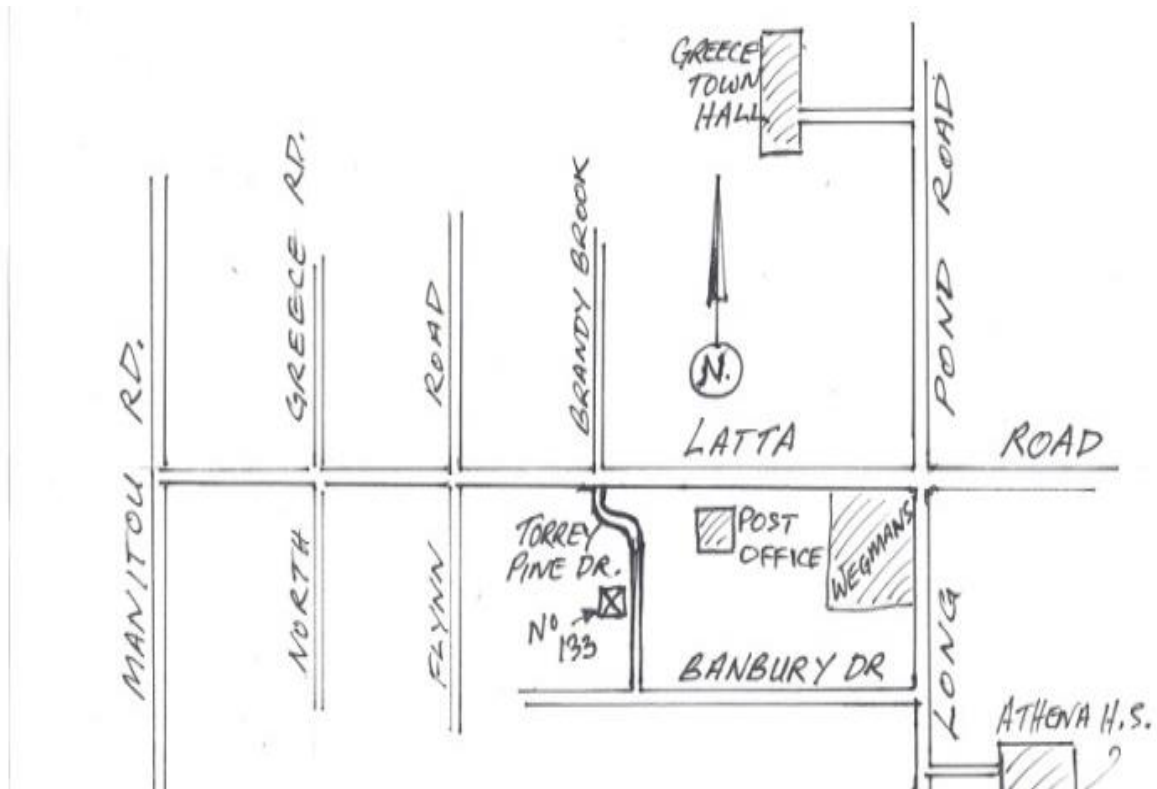
**At 133 Torrey Pine Drive, Rochester NY 14612**
